Club Dues

Cannons Club dues are in one or three equal installments however, a 6 or 8 payment installment can be arranged for special circumstances and situations. Please contact the registrar for more information.

Team will practice a minimum x 2 a week. Optional skill sessions and Goalkeeper training are available to all Academy and select players. All teams will practice in December and January during the 'off season'.

Cannons Soccer Club dues are similar to tuition. They are not optional. If you are unable to attend a tournament or train for any reason including illness or injuries (except as noted below), no refund is due. No adjustment or reduction in Club Dues is allowed. Players who suffer serious injuries lasting more than three months, however, may submit a request to the CCSA Board of release of payment of Dues for that period.

Allocation of Dues to Services Provided by the Cannons Soccer Club

Items paid for by your dues include: Coaching, team training, skills training, goalkeeper training, GYSA League Fees, Club Administration Expenses (insurances regional, & national; communications, document management, etc.), Field Maintenance and Usage, Registration, Referee Assignments, Coach education, County Fees.

Financial Aid

Types of Financial Aid:

Payment Plan: This is not a scholarship and does not reduce the fees due to the club by the family. Instead it allows the family to pay fees on a schedule that is customized to your family and is different from the payment schedule as listed on the Payment forms and contracts. It will be a 6 or 8 installment payment plan.

Financial Aid: The aid that a family can receive ranges from 25% to 100% towards registration/and/or trainer fees depending on the application status and available funds. Applicants must fill out the financial aid application form and submitted by the last night of try-outs.

All families receiving Financial Aid are expected to volunteer an additional 20 hours per season to help the CCSA provide the best soccer program in Metro Atlanta. These hours may include being a field marshal, field maintenance or any other capacity deemed appropriate by the CCSA BOD and SFA Committee.

Payment Default

The Cannons Soccer is a membership organization. Unpaid dues represent funds not available to meet Club expenses. Any player delinquent in dues by 10 days or more will be notified by the Club, and suspended from participating in any Club/team activity. A late fee of \$25 will also be added to the installment.

Team Expenses

The Club Dues do not cover team expenses, which include but are not limited to, tournament entry fees, referee fees for friendly games, optional camp fees and coaches traveling expenses. Teams will collect team fees according to their team financial policy. Players not paying team fees within 10 days of the assessment due date will be subject to being suspended from participating in any Club/team activity and will be subject to a late payment fee of \$25.

Release Policy

For whatever reason, if a player quits or wishes to be released from the Club, all fees to the CCSA will need to be paid in full as per GYSA Rule 310.2d.

(310.2d Once a select program player is rostered to a team, that player’s financial obligation as published by the club and accepted by the player must be satisfied before a transfer will be approved.)

Additional Information

Special Note 1: Club policy is to allow coaches to train more than one of the club’s teams. Therefore it is inevitable that team coaches will occasionally be unable to attend certain games. Every effort will be made by the Club to arrange for a suitable alternative staff member to coach the team.

Special Note 2: Club soccer is a competitive environment. Efforts are made to attract good soccer players during tryouts and throughout the year. Rosters can and will change.

Special Note 3: The Cannons Soccer Club is able to operate successfully due to the involvement of parent volunteers. Each family is expected to volunteer 10 hours of their time to help the CCSA in it’s events, day to day running and tournaments.

The above are part of Cannons soccer and do not affect a family’s commitment to pay the Club Dues when due.
